The Reentry Navigators will be collecting the artwork through March 15th, 2024, with the required property disposition form and release/approval to use.

Washington Community Partnership for Transition Solutions Services (CPTS) is made up of agencies and individuals working together to support successful transitions for people returning to our communities after incarceration. CPTS provides opportunities for reentry service providers, educators, faith-based and community organizations, Tribal Nations, and individuals affected by incarceration to network, share expertise, identify, and refine best practices, and foster sustainable partnerships.

In preparation of our Annual 2024 CPTS Summer Institute Conference with the theme: <u>Thriving Through</u> <u>Connection & Community</u> we're seeking talented artist to design the graphic they feel expresses the theme of the event.

Each submittal will include a brief description to include:

A short biography, what inspired them to create the graphic, and how it relates to that person's reentry journey. The winning graphic will be featured on all printed and electronic media to be distributed statewide promoting the 2024 Summer Institute.

ENTRIES MUST BE SUBMITTED BY Friday 03/15/2024.

- Submissions must be paintings, drawings, watercolors or print only. No depictions of your minor children, no spoken art mediums (no songs, rap, poetry), and nothing depicting violence. Please note submissions will not be returned.
- Fill out a property disposition form to "donate" the art per policy. This would be submitted with the artwork.
- Sign a release allowing your artwork to be used and understand that the artwork will not be returned to you.

About the Artist: Please provide a short biography about you that will be displayed with your graphic at the 2024 Summer Institute. Please include what inspired you to create this graphic, and how it relates to your reentry journey. Include struggles, barriers and concerns you have and will work on overcoming, along with your accomplishments. Please share appropriate thoughts you may want heard by the conference attendees. Please complete and attach the entry form with your artwork. You may submit entries to the facility reentry navigator.
